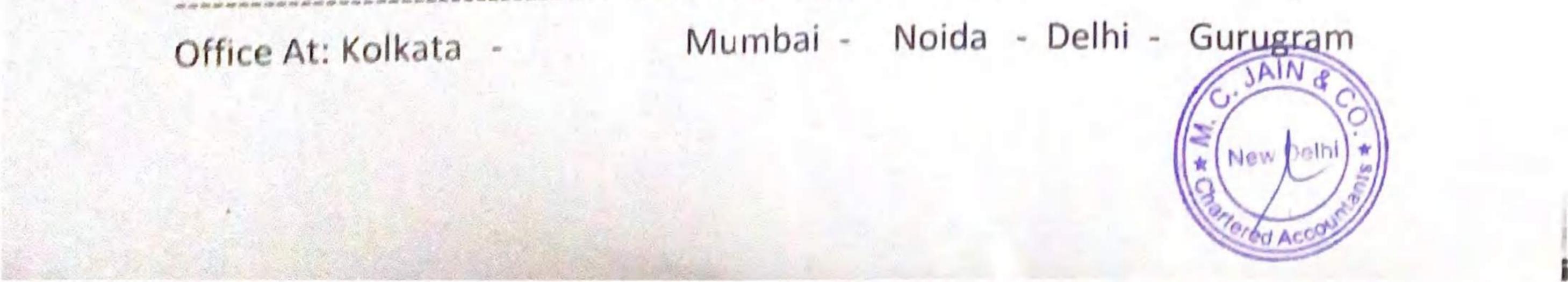

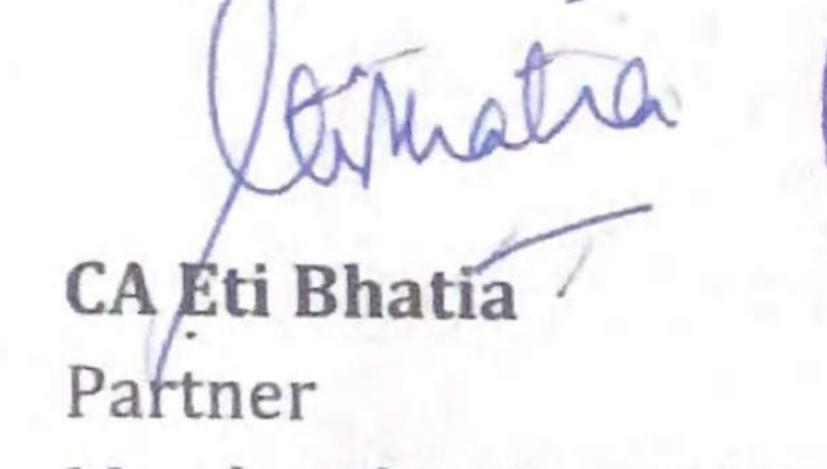
assurance than an audit. We have not performed an audit and, accordingly, we do not express an audit opinion.
